MAY 2010 CVARC BOARD MINUTES

The March 2010 Cedar Valley Amateur Radio Club Board of Directors' meeting was held May 13, 2010 at the Kenwood United Methodist Church. President WA6GFD called the meeting to order at 6:36 pm. Others in attendance were: N0XZL, W0HKR, N0GUD and KD0JCX.

In the treasurer's absence, WA6GFD stated that the checking account balance was \$2,840.23.

The Midwest division of ARRL expressed interest in holding their convention in conjunction with our Hamfest. There is not enough lead time for this year, but may be a possibility for next year.

W0HKR moved to approve the minutes for the March Board meeting. N0XZL seconded the motion and the minutes were approved unanimously by the Board.

N0XZL moved to approve the minutes for the April Board work session. W0HKR seconded the motion and the minutes were approved unanimously by the Board.

W0HKR discussed upcoming events. The first event is the Marion Arts Festival 5K run on May 15. Next is the Pigman Sprint on June 6 at Pleasant Creek Park in Palo. The Diabetes bike ride is on June 26. Field Day is June 26 and 27, so volunteers will be needed to cover both events. For Field Day, W0MRZ is heading

up the GOTA station and KI0OB is leading the voice station. A lead person is needed for the CW station. After setup on Friday, there will be a picnic. At next month's meeting, plans will be finalized for Field Day and the Diabetes ride. W0HKR is sponsoring Lawrence Robinson and Alex Hernandez for the Diabetes ride. Members are invited to pledge, if they're so inclined.

KD0JCX reported that the required Form 990-N has been filed with the IRS and the registered agent for the club has been updated with the state of Iowa.

N0GUD gave a brief report on the weather net for the storms on April 6. He also has obtained 2 software licenses for Interwarn, and reported that there will be another Duane Arnold drill on May 19.

WA6GFD reported that there will be a kit building meeting, possibly in July, and a fox hunt at a later date.

N0GUD moved, W0HKR seconded and the Board unanimously approved a motion to adjourn the meeting at 7:20 pm.

The evening's presentation was given by Albert Helfrick, W2BLA on EME (Moon bounce).

WA6GFD announced that the new Bandspread editor is W0MRZ.

Scott, N0GUD moved to approve the minutes for the April meeting. W0JMK seconded the motion and the minutes were approved unanimously by those present.

In the treasurer's absence, WA6GFD stated that the checking account balance was \$2,840.23.

NOGUD reported that there will be another Duane Arnold drill on May 19.

Rick, N0XZL has fliers for the Hamfest to be distributed.

WA6GFD reported that the club had been approached to sponsor the state ARRL convention, but we are committed to the Teamsters Hall this year, and the facility is not large enough to accommodate both events. This year the ARRL convention will be held at the fairgrounds in conjunction with the West Liberty Hamfest. Maybe next year we will consider sponsoring the ARRL because we would benefit by sharing mailing costs and have better coverage, and would not be committed to the Teamsters Hall.

Nancy, KD0JCX reported that the required Form 990-N has been filed with the IRS.

Ken, W0HKR reported on upcoming public service events. The Marion Arts 5K run is May 15 and new hams are welcome to participate. The Pigman Sprint is on June 6 and volunteers are still needed.

WA6GFD noted that Field Day is June 26 and 27. Come Friday afternoon to set up everything except the radios. A point of contact person is still needed for the CW station.

WA6GFD reported that the Technician Class was successful, and that all but one participant passed the technician element. A General class may be held this fall.

WA6GFD said that there will be a kit building meeting, possibly in July, and a fox hunt at a later date.

W0HKR stated that there will not be any dragon boat events in the foreseeable future due to the associated expenses and the lack of sponsors.

AK0R moved, W0HKR seconded and those present unanimously approved a motion to adjourn the formal meeting at 9:23 pm.

Our presentation this month will be a 2 fold meeting: led by Steve Jones, we will be discussing Field Day and preparation for the event. Dave Huff, W0IM, and Robert Klaus, N0YWB will be have a presentation on fox hunting. At the end of he presentation we will take order for purchase of fox hunting kits for a future meeting, most likely the Aug meeting, for a build session.

ARES PLANNING COMMITTEE MEETING MINUTES – 6 MAY 2010

- Introductions
 - Attending are AC0HB, WA6GFD, W0HKR, KD0JCX (and spouse Dave), KD0IOL, KD0HF, KF0VF, KC0SKM, and WA0FBX
- Review of past month's activities
 - DAEC Drill 7 April
 - This went reasonably well. Only major issue for our portion was that the paging system didn't get the entire list. This has been fixed.
 - Tried to maintain contact with state EOC via HF and VHF linked repeaters. We were only able to maintain contact for a short time on HF, and never made contact on VHF. We will work this before the 19 May drill.
 - Storm event 6 April
 - This was a significant storm, but we had a lot of people out that evening.
 - The big item that evening was a tornado (per spotter reports) near Alburnett. It was confirmed as a strong wall cloud or funnel by two spotters, and a third reported debris. On this, the siren was activated, generating discussion of the siren system.
 - This was one of the better storm nets we've run...we should use it as an example for others.
- Review action item list
 - CRPD station
 - The equipment is available and ready to be programmed.
 - Our area at CRPD is very nice, but not so close that we and the dispatchers will talk over each other.
 - When we get the radios up to CRPD, we should conduct a general radio check of all installations:
 - CRPD
 - Sheriff's office
 - EOC
 - St Luke's
 - Mercy
 - Radar at Collins (known to be

working, but want to check simplex to others)

- Independence Day activities
 - Fireworks on Mays Island
 - NOGUD will contact EMA about the mobile command post and arrange for a liaison there if possible.
 - We will run a net on site on 146.505 simplex, as in years past.
 - As the command post antennas are fairly close to each other, it may be better to have net control at another location to avoid desense and noise to the other radios and operators. If the CRPD station is complete, and we have access, that would be the ideal location!
 - We will run the usual Sunday ARES net on 146.745 at the usual time, for those who are not downtown or who care to try it from there.
 - Some discussion followed on the condition of the south receive site, which is having some problems. WA6GFD will contact the repeater trustee.
 - Please note that the downtown area, while recovering, still has many problems relating to the flood. Some are:
 - The parking garage by the river is closed.
 - A good portion of the east bank and parking therefore is closed for federal courthouse construction.
 - The grassy plaza on the island is not known to be able to support the weight of thousands of spectators, stages, equipment. Also, the fireworks, at last news, would be launched from that plaza.
 - Because of that, the bridges will be closed during the fireworks as well, which possibly means moving people from the bridge just before.
 - As such, we need to be aware of the logistics, and perhaps to lend a hand if needed.
 - Siren Criteria
 - Donna Dubberke from NWS in Davenport presented at the April EM
- Commission meeting about alerts.
- In Illinois, as a result of siren issues (people ignoring them, etc), the hazardous weather outlook (HWO) and warning texts will have tagged information at the bottom with maximum wind and hail data. Straight-line winds over 70 mph and hail over one inch diameter will get sirens now along with the more tradition situations.
- ARES/CVARC will investigate getting handheld anemometers for spotters in the field.
- Ms Dubberke and the Commission stated that businesses need to establish policies for what to do when the sirens are sounded.
- Net Schedule
 - We discussed the current Sunday net schedule, especially as it pertains to absences during the summer (particularly NOGUD and KB0NRU, who work Sunday evenings during that time). Things are worked out.
- Spur on CVARC repeater
 - An operator near Central City reported hearing the 146.745 repeater in CR on 146.940 (output of another repeater in a northern county). Some time back, KC0OX (SK) investigated a similar issue and found that it happens only when the CVARC repeater and another area repeater were keyed up. Several of us have been monitoring since, but have not caught the interference. If anyone hears anything, take notes and report to WA6GFD.
- Jones County repeater tower
 - Our compatriots in Jones County will lose their repeater's receive site tower soon.
 - The tower is not in great condition, and the owner is not renewing the lease as a result.
 - Three hams have offered space for a tower.
 - They might also be able to get space on a county tower.
 - Since the system is being redone, the transmit site may change as well. (This

might be required, given the unique relationship of 2m repeaters with WMT AM.)

- The next few months will involve some experimentation to determine the best locations.
- They must be off the tower no later than September, but they're thinking it will happen before August.
- Other items
 - Formal Traffic Training (left from February)
 - NOGUD still working this.
 - WX alerts to our pagers/phones active again!
 - Pagers/cell phones will get t-storm and tornado watches and warnings.
 - System originally had special statements as well, but this is of limited use and pinged the phones too often.
 - Linn and all contiguous counties are currently on the list. This does mean we get a number of alerts of no relevance (WX in Black Hawk or Cedar Counties that is moving away from us, for example), but since WX does sometimes come from there, we'll leave them up for now.
 - Radar instructions (AC0HB)
 - Micheal did a nice job on this.
 - Clean copies will be left at the radar. WA6GFD, NOGUD, and AC0HB will go to radar for a training session and talk about what to put on a "nifty-card" menu at the radar.
 - Frequencies
 - NOGUD and others will go over the frequency lists on the website and update as necessary.

For those who signed up to make the HANDI-FINDER kit and were not able to pay for your kit at the meeting, please get with me so we can get the order together and get the kits ordered. This looks to be a nice simple project and will be a lot of fun to test and experiment with.

Look forward to seeing you all at the next meeting on 10 June.
